Prior Written Notice ilo juōn Kajin eo Maroņ Mejeļe

Prior written notice eo ej aikuj jeje ilo juōn kajin eo me aolep remaroņ mejeļe im ej barāinwōt aikujin jeje ilo kajin eo am, ak bar juōn wāween ennaanik doon ijellōkin ñe ejjab juōn wāween eo ekkar ñan kōmmāne.

Family Educational Rights and Privacy Act (FERPA) eo ej juōn kakien an federal me ej lejok jet mālim ko ñan rūtto ro ñan etale im, lale rekkootin jeļāļokjen ko an ajiri ro nejier. Mālim ko iumwin FERPA rej etal jān jinen im, jemen ri-jikuuļ eo ñan ri-jikuuļ eo ñe ri-jikuuļ eo erōm, 18 an iiō ak ejino jikuuļ ko reutieļ jak (e.g. juōn college ak university), eo wōt ewaļok mokta iaer.

Ta In Rekkoot In Jikuuļ?

2. Rekkoot ko me juōn agency ak jikin jermal eo (waanjoñak, district in jikuuļ eo am) ak juōn doulul eo ej maķūtķūt ñan agency eņ.
