# CELINA CITY BOARD OF EDUCATION BOARD MINUTES MONDAY, FEBRUARY 10, 2025 HIGH SCHOOL LECTURE HALL 6:00 p.m.

This meeting is a meeting of the Board of Education, in public, for the purpose of conducting the School District's business, and is not to be considered a public community meeting. There is a time for public participation during the meeting as indicated in the agenda.

The Celina City Board of Education met in regular session on February 10, 2025 at 6:00 p.m. in the High School Lecture Hall. President Adam Schleucher called the meeting to order and led those in attendance in the Pledge of Allegiance. Mr. Clouse, Mr. Schleucher and Mrs. Sommer answered the roll call. Mr. Huber and Mr. Huelsman were absent.

On a motion by Mr. Clouse, seconded by Mrs. Sommer, the Board added Resolution #3 with Attachment VIII in the Treasurer's Report section and set the remainder of the agenda as presented.

- 3. Facilities -- Phil Metz addressed a question that came from the Elementary open house which regarded signage in the new building. There will be a review of the signage, such as directional and safety type signs in the Elementary building to ensure the quantity is sufficient. The old CES building demo is in progress and will be completed soon, maybe two more weeks and it will be all cleaned up. At the 7-12 building site, the crew continues to work on steel and underground plumbing.

## **PUBLIC PARTICIPATION**

Theresa Howick – Mrs. Howick was questioning the size of the new PK-6 building thinking there were an additional eight rooms added. Mr. Metz said the new building plus the renovated CIS space was designed to accommodate the ADM of the PK-6 classes. Mrs. Howick attended the open house at the new Elementary building and wondered why teachers were not in attendance. Superintendent Gessler stated the teachers' union contract did not require them to attend, but those that did attend were very much appreciated. Mrs. Howick also made the comment that the district collected \$16.5 million in 2021, \$16.7 million in 2022 and then \$20.2 in 2023 in property taxes, which is a lot of money, and we seem to be spending more than we should be. She also stated 76% of her property taxes go to the school. Where will the building maintenance personnel that are located under the stadium be housed? Mr. Metz said it hasn't been decided yet.

<u>Tim Homan</u> - Mr. Homan voiced his concern regarding the survey. Some of the questions he expressed concern about included questions 5, 6, 14 and 15. He said question #6 did not include atmosphere as a choice and that is exactly why he is doing this. You would have to write it in and that is the #1 thing he is fighting for. Additionally, there was no mention of the fieldhouse in the survey. It's just a generic survey. He asked if the results were going to be made public, and the response was yes. Mr. Homan stated that he hoped the board members really have an open mind. Lastly, he stated he thought the survey is a starting point.
