- B. Treasurer Authorization:
  - 1. Pay all bills as they are presented, provided those funds are available in the appropriated accounts approved by the Board of Education.
  - 2. Make modifications within the appropriations as needed.
  - 3. Invest interim and/or inactive funds at the most productive interest rates whenever funds are available.
  - 4. Request advances on local taxes due to the school district from the County Auditor when funds are available.
  - 5. Borrow money if needed for the general fund, along with the President.
  - 6. Approve The People's Bank, First Financial Bank, Citizen's National Bank, Chase Bank, Fifth Third, Park National, Hilltop Securities, and Star Ohio as depositories for public funds.
  - 7. Attend public records training as required to represent the Board of Education.
  - 8. Establish reimbursement rates for travel expenses.
- C. Superintendent Authorizations:
  - 1. Appoint Superintendent and Treasurer as purchasing agents for the school district during CY 2025.
  - 2. Accept resignations between board meetings subject to ratification by the Board (to authorize the Superintendent, on behalf of this Board, to accept resignations which have been submitted by employees during times when this Board is not in session, subject to ratification by the Board; provided, however, that upon ratification by the Board, such resignations shall be deemed effective as of the date and time of the Superintendent's acceptance).
  - 3. Hire employees between meetings subject to a subsequent vote of ratification by the Board (to authorize the Superintendent, during periods when this Board is not in session, to make offers of employment directly to candidates for either teaching or nonteaching positions on behalf of this Board, subject to subsequent vote of ratification by this Board; provided, however, that upon ratification by this Board, the employment shall be deemed effective as of the date and time of the employee's acceptance of the Superintendent's offer).
  - 4. Submit applications for federal and state programs.

- 5. Appoint the Superintendent as the authorized representative to the Mercer-Auglaize Area Schools Employee Welfare Benefit Trust.
- D. Board Authorizations:
  - 1. Establish a Board Service Fund for the Celina Board of Education in the amount of <u>\$7,500.00.</u>
  - 2. Set Board member compensation at \$80 per meeting for each individual for a maximum of eighteen (18) meetings per year; per Board Policy 0147.
